REGISTER OF MEMBERS' INTERESTS

A register is maintained showing the interests of Members of the Royal Commission. It consists of declarations made annually by each Member. It is kept by the Secretariat and included on the Commission's web site. Anyone requesting to do so may inspect the register and obtain a copy of any information it contains.

The categories of interests listed are based on those recommended for this purpose by the Department for Environment, Food and Rural Affairs. The intention is that all significant and relevant interests should be included, whether they are of a financial or a non-financial nature. A suggested test is whether the general public, knowing the facts of the situation, might reasonably think that an interest should be entered in the register. It will be helpful to include a brief indication of the key activity of any body mentioned, if that is not apparent from its title.

The register will in future be updated in January each year. If any addition or change to a Member's relevant interests takes place in the course of a year, s/he is asked to notify it to the Office Manager within a month, so that the information can be placed on the register.

If a Member is in doubt about whether to include a particular interest in the register, s/he is invited to discuss the matter with the Secretary to the Commission.
